

PRESIDENT'S REPORT

The Board of Management is determined to see many improvements made in the facilities provided at the Base Hospital. These improvements will include new improved ward accommodation, Operating Theatres, Obstetric Unit, Intensive Care Unit, Children's Ward, Pathology Department, and Geriatric Wards in association with a Day Hospital.


The Board of Management has received enormous $encou_ragement$ in its objectives of developing the Wimmera Base by the action of the Community served by the Hospital in supporting so st_r ongly the Hospital's Centenary Appeal.

Each year in this report the President thanks those persons in the community who have helped the hospital. In this particular year the hospital has probably had more supporters than in any previcus year on record. In last year's report, the President, Mr. Johns, expressed pleasure that Mr. E. G. Brownstein and Mr. R. Bethel had agreed to appointments as Director and Chairman respectively of the Centenary Appeal. The Appeal is now, of course, in full swing and although their target is huge and although there is still a long way to go, I am sure that everyone in the Wimmera area served by the Hospital would agree that Mr. Brownstein, Mr. Bethell, their Committee Chairmen and their large band of helpers and organisers, have brought the Hospital closer to the community it serves than it has been for many years. Quite apart from the extraordinary success of their fund raising, they have created a public interest in the hospital which will continue its benefits long after the Appeal closes This hospital was saddened to hear of the death last September of Dr. John Lindell, former Chairman, Hospital's and Charities Commission. Dr. Lindell was a very good friend of this hospital. Mr. Alec Md ellan, his Deputy, was appointed for a brief period until his retirement and we were delighted to have Mr. McLellan officially open our new Wimmera Hospitals' Group Linen Service building in February of this year, which we understand was one of his last duties prior to retirement. The Board of Management extends its congratulations to Dr. E. M. Wilder, Mr. R. L. Thomas, and Mr. F. W. Cremean on their appointment as the new Hospitals and Charities Commission and I assure Dr. Wilder and his Commissioners of the support of this hospital's Board of Management in their task.

I wish to extend my thanks to my colleagues on the Board of Management and to the Senior Officers and all staff of the hospital for their very efficient support during the year. Mr. Bill Humphreys is to be congratulated on the achievements made by the Board of Management during the brief period he cccupied office of President and while we acknowledge our loss in his t_{ran} for io Shepparton, we never-the-less wish he and his family every success in that City.

Mr. R. W. Shepherd, who has served the Board of Management so well since his appointment in 1950, was this year appointed Chairman of the Board of Directors of the Victorian Hospital's Association Limited. This Association's objectives and activities have been considerably broadened and the Base Hospital is fortunate in having such a close association with the Victorian Hospital's Association Limited through Mr. Shepherd.

In conclusion, I hope that the whole community served by the hospital will join us in celebrating the Hospital's Centenary this year and that you will also continue to provide your support during the second century.



MANAGER'S REPORT

JOHN WALTER, MANAGER This has been an extraordinarily eventful year for the Wimmera Base. The Hospital wards have worked under considerable pressure, with in-patient numbers at their highest level on record despite greatly increased domiciliary services — Meals on Wheels increased to 14,508 and home nursing visits increased to 3,959.

We have seen the very successful launching of an appeal aiming to raise \$250,000 for re-building and we have reached agreement with the Hospitals and Charities Commission on a scheme of re-development, subject to available finance.

During this current year and with the assistance of the Hospital's and Charities Commission, we have seen the completion of the Wimmera Hospitals' Group Laundry Service building, a Maintenance Services building, the installation of new Steam Raising Plant and the construction of a new electrical sub-station. These works totalled \$600,000 and paved the way for services for our future building program. At the time of preparing this report, we have received approval in principle from the Australian Government Department of Social Security for the construction of a 50 bed Frail Aged Unit. Planning for a Geriatric Day Hospital and a Pathology Department is quite advanced. An Intensive Care Unit must be commenced in the near future and will receive high priority in our future discussions with the Hospitals and Charities Commission.

In January 1974, Miss Lesley Woolley announced her retirement. Miss Woolley had given the Hospital 16 years devoted service and her wonderful personality will be missed by all, with the possible exception of the district yabbies. The Hospital was extremely fortunate in appointing Miss Joan Matuschka to replace Miss Woolley. Miss Matuschka trained at Wimmera Base Hospital and completed her Midwifery training at the Royal Women's Hospital. In addition to receiving a Diploma in Nursing Administration at the College of Nursing, Australia, in 1965, Miss Matuschka has experience at the Alfred Hospital, Melbourne, The Royal Freemasons Hospital, London, and immediately prior to her appointment, was Matron at Ararat and District Hospital.

CENTENARY APPEAL EXECUTIVE

MR. E. G. BROWNSTEIN, DIRECTOR This Committee began to function in August 1973 under the dynamic leadership of Mr. Bob Bethel who, as Chairman of the Committee, gathered together a group of men and women to form the Centenary Appeal Executive Committee.

This enthusiastic group was charged with the challenging task of raising one quarter of a million dollars to enable the major hospital building programme to commence to the order of $2\frac{1}{2}$ million dollars.

The Appeal was to run from February to November 1974. The ground work began in November 1973 with a broad approach to all people in the Wimmera through the news media (Mr. Alan Finch) and through talks to Service Clubs, Church Groups, workers in industry in tea breaks, letters to City Council and Shire Council outlining the plans for the Appeal. This culminated in the Gala Opening on 1st February. Professor Maurice Ewing of the Royal Melbourne Hospital, Department of Surgery, underlined the community importance of the Base Hospital Appeal and flowing from this sentiment the appeal has received the support and interest of a wide cross section of the people of the Wimmera-Mallee. Expressed in human terms this has been a most gratifying result and brought to light a most optimistic view of a healthy community spirit in the Wimmera.



T. E. (TOM) CONROY



Thomas Eli Conroy is the longest serving member at present on the Board of Management of the Wimmera Base Hospital and for most of us, as long as there has been a Horsham Hospital or a town named Horsham, there has been Tom Conroy.

Tom, as he prefers to be called, has a record of service to the Hospital which is only surpassed by that of the late Mr. David Anderson. Mr. Conroy was first appointed as a Town Member of the Committee of Horsham Base Hospital on 13th August, 1935. Since that time he has served the Hospital faithfully and well; a fact which was recognised when he was made a Life Governor of the Hospital in 1964. Mr. Conroy came to Horsham from Donald very early in his career. He eventually became Manager of Chandlers Hardware. It was at this stage that his interest in civic and community affairs became most prominent. For many years he was the President of the Horsham Chamber of Commerce. In 1947, he was elected to the Horsham City Council and remained on the Council until 1965. From 1956 to 1958, Mr. Conroy was Mayor of the City of Horsham.

But this is not the full extent of the Conroy involvement in Horsham community affairs. Mr. Conroy was for a long time involved with the 3LK Appeal Committee and gave a lot of his time travelling to other towns in the region in this capacity.

During the years of the Second World War, he was actively engaged in war time fund raising activities.

Also involved in a very real way with the Horsham community was Mr. Conroy's wife. Mrs. Conroy will be well remembered as a renowned music teacher who taught many hundreds of Horsham children over the years.

Like many of those Committeemen with whom he served on the Board of the Wimmera Base Hospital when first appointed in 1935, the name of Tom Conroy will for a long, long while be a part of Horsham's history.


WIMMERA HOSPITALS' GROUP LINEN SERVICE REPORT

We express our appreciation also, of course, to the Hospitals and Charities Commission for providing the finance necessary for the building's construction and our Architect, Mr. Arthur Russell for his advise and service leading up to the letting of this contract and the consequent supervision until completion of the building.

The Wimmera Hospitals' Group Linen Service operates independent of the Base Hospital and is required to manage within a budget of charges made to participating Hospitals for the supply and laundering of their linen requirements at the rate 28c per kilogram. The average output of laundry processed in the new building since its opening, has been 11,500 kilograms per week and there is scope for this production to be increased if other institutions wish to obtain the service. The Group Linen Service completed the year with a surplus of \$9,119 at June 30th after providing for depreciation and provision for long service leave.

A Linen Service Advisory Committee has been formed with representatives from participating hospitals and has elected Mr. R. B. Stewart of the Wimmera Base Hospital Board of Management as its Chairman. This Advisory Committee investigates suggestions made to it for improvements in services provided.

One of the fields opening up is the training of new medical graduates in Family Medicine and we hope that in the near future this hospital will be approved for attachments under this scheme. This will help to create an interest and training not only for those entering general practice, but also for those ultimately destined for other specialties.


Dr. Chris Foord has been a welcome addition as Honorary Assistant Medical Officer to the Hospital during the year.
