To the Governors and Subscribers,—

The Committee of Management of the Ballarat District Benevolent Asylum have the honor of laying before you their Fifty-First Report, together with the Balance Sheet, duly audited, for the year ending 30th June, 1908.

By reference to the Balance Sheet you will see that the income from all sources amounts to £12,103 15s 1d, and the expenditure £7993 8s 2d, including £2064 1s 1d paid for buildings and laundry machinery.

1.—THE ASYLUM.

The daily average number of inmates for the year was 302.43, being 5.07 less than last year. The number of inmates in the Asylum on the 30th June, 1908, was 222 males, 84 females; total

306; being a decrease of 5 males, and an increase of 8 females as compared with the previous year.

The daily average of inmates during the year was 302.43, as against 307.50 for the previous year. The average cost of maintenance per head was £16 16s 9 $\frac{1}{4}$ d, as against £15 7s 2 $\frac{2}{5}$ d for last year.

2.—LYING-IN HOSPITAL.

The number admitted to the Lying-In Hospital during the year was 45 adults, two adults remaining from last year. Total 47 adults. Thirty-nine children were born, viz., 17 males and 22 females. Forty-three adults and 38 children were discharged. The number remaining in the hospital on the 30th June, 1908, was four adults and one child. The average period which adults spent there was 30.42 days.

3.—OUT-DOOR RELIEF.

The amount expended on out-door relief during the year was £840 5s 0d, showing a decrease of £16 11s 6d as compared with last year. The average number of recipients per week for the year ending 30th June, 1908, was 135.11 adults, and 81.96 children, total, 217.07; and for the previous year 139.79 adults, and 82.88 children, total, 222.67, being a decrease of 4.68 adults and .92 children. Total decrease of adults and children, 5.60. The average cost per head per annum for each adult and child was £3 17s 5 $\frac{1}{3}$ d, and per week, 1s 6d, as against £3 12s 4 9-10d, and per week, 1s 4 $\frac{3}{4}$ d for the previous year. The total number of persons on the books, in-door and out-door, on the 30th June, 1908, was 520, as against 535 for 1907.

4.—REPORT OF THE INSPECTOR OF CHARITIES.

The Inspector made his annual official visit to the Asylum, and reported favourably upon the condition of the Institution, the general health of the inmates, and also that he found the books and accounts in good order.

5.—SPECIAL DONATIONS AND EFFORTS.

The Committee again acknowledge with cordial thanks the continued liberal donations and special efforts put forth to assist the funds of the Institution, viz.:—The Birthday Carnival, per Mr. Theo. Saunders, £80 0s 4d; the Ballarat Grocers' Association, £40; the Victorian Railway Military Band Concert, per D. Regan, £9 10s 5d; the Bow Leong Society, £30; the Chinese Gardeners, per Tong Wai, £25.

6.—BEQUESTS.

The bequests received during the year total the handsome sum of £6031 12s 0d.

7.—OFFICE-BEARERS AND MEMBERS OF COMMITTEE RETIRING.

The meeting will have to elect a President, two Vice-Presidents, Treasurer, and seven Members of Committee, viz.:—Messrs J. N. Dunn and Geo. Lovitt, and Rev. Thos. Guilfoyle, who retire by effluxion of time, Mr. A. Ronaldson (the retiring President), and Messrs A. Levy, A. J. Pittard, and D. B. Wheeler, who were appointed by the Committee to the vacancies caused by the demise of the late Mr. William Gale, Mr. Joseph Phillips, and the Hon. David Ham. The abovenamed gentlemen are all eligible, and offer themselves for re-election: The three Hon. Medical Officers, Hon. Oculist, Hon. Solicitor, and two Auditors also retire, and offer themselves for re-election.

8.—GENERAL.

During the year very extensive additions and improvements have been made at a considerable outlay. Amongst these may be mentioned a new laundry, fitted with up-to-date machinery, comprising a washing machine, a hydro extractor, and mangle, all

driven by an electric motor, thus enabling the work in that important department to be got through with effectiveness and despatch, in striking contrast to the old condition of things; bath rooms for each of the sick-wards and new bath rooms for the ordinary inmates, all well and completely fitted up; a new dining room for the staff; an isolation ward in connection with the lying-in department; a large wide verandah at the back of the building, and a balcony for the women's sick-ward, both giving great comfort and pleasure to the inmates, especially the invalids in the sick-wards, who, by means of the ingenious patent bed carriage lifts now in use, are, without being disturbed in their beds, brought out on fine and sunny days and treated to a luxury to which many of them have been strangers for years. The Institution thus so much better equipped is in a position to carry out its work of mercy and helpfulness to the old and needy so as to make their lot brighter and happier in their declining years. Those whose offerings have enabled your Committee to carry out these much needed improvements are true benefactors to their less fortunate fellows, and the Government, by a vote in aid thereto, are spending the money they have entrusted to them in the best possible way.



David Ham, each of whom had served the office of President, and Mr. J. Phillips having also held the office of Treasurer. They had each rendered long and faithful service on the Board of Management, the Hon. David Ham having a record of 33 years, Mr. Phillips 31 years, and Mr. W. Gale 20 years.

To the Ministers and numerous other workers in the Churches throughout the City and Town, who had ministered to the spiritual need of our inmates; to those who in connection with concerts and other entertainments given pleasure and amusement; to the many who have by donation of books, magazine papers, and creature comforts, rendered no mean help to our Committee; to Mr. George Lovitt for his labor of love in connection with his well known and highly appreciated tobacco fund; to the Press for its advocacy of our work, and the constant keeping of our claims and needs before the public; and to all others who have in any way rendered us

helpful and praiseworthy service, we tender our heartfelt thanks.

We have particular pleasure in recognising the faithful and valuable services rendered by each and all of our staff of Officers and workers—the Hon. Medical staff, the Hon. Oculist, the Hon. Solicitor, Non-Resident Medical Officer, Secretary, Superintendent, Matron, Maternity-Ward and other Nurses, Wardsmen, Gardener, Collector, and working staff generally. All have had the best interests of the Institution at heart, and have done what they could to make it as successful as any that could be found throughout the Commonwealth. As President, I have to acknowledge the valuable help and ready co-operation rendered me throughout my year of office by the Officers and Members of Committee, their faithful work as visitors, their close and punctual attendance at our various meetings, and their general work in the interest of the Institution have materially assisted me, and made my term so much the pleasanter.
