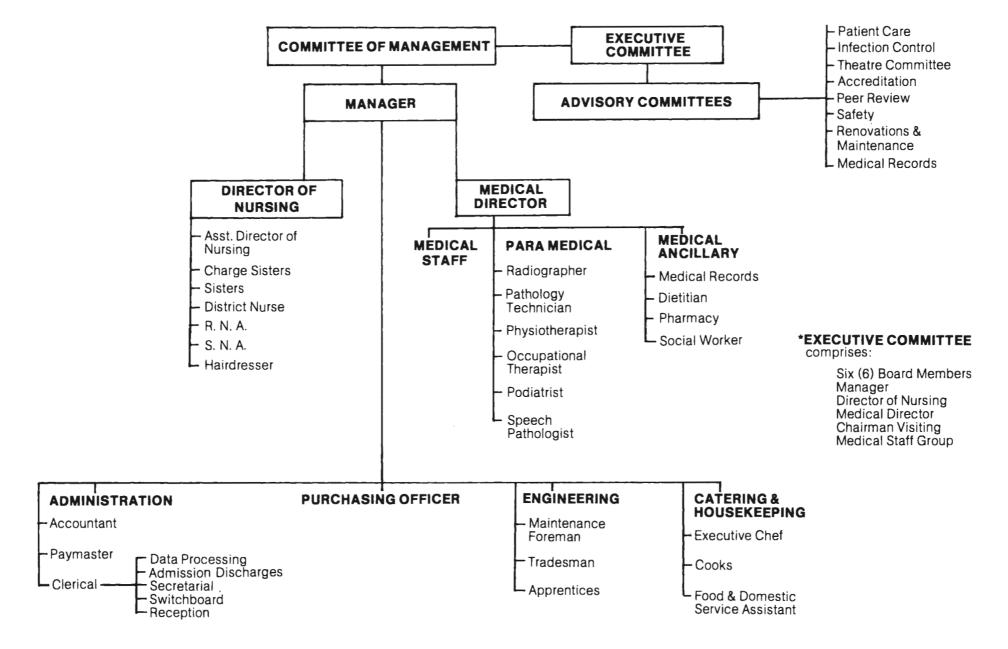

REPORT OF THE COMMITTEE OF MANAGEMENT

To the Life Governors and Contributors, Ladies and Gentlemen,

The year under review has once again seen the public hospital field subjected to substantial cost increases whilst approved operating budgets decreased in real terms. This has meant that the management of financial recources is increasingly becoming the pre-occupation of Hospital Boards of Management, and this hospital Board is no exception.

The most stringent monitoring of our financial resources still resulted in this hospital incurring a substantial cash deficit in the year under review.

The main reason for this cash deficit was due to the introduction of the "user pay" philosophy which was introduced in September 1981, which had as one of its aims that hospitals were entrusted with the responsibility of collecting a greater proportion of its income direct from patients. As is detailed later in this report the hospital had less bed days this year than last year which meant less opportunity to generate sufficient revenue to achieve our revenue budget set by the Health Commission.

It is anticipated that we will be subjected to another health care system from February 1984 labelled "medicare". Whilst not knowing at this stage the details of how the medicare system will operate it is hoped that nobody in the community will be denied

access to quality health care, that the health insurance system is simplified and stabilised and finally and most importantly that the cost of "Medicare" will not be an intolerable burden on individuals or the national economy.

BOARD OF MANAGEMENT

Two members of long standing Cr. Chilvers Hutchings and Mr. Tom Sainsbury resigned their positions during the year. Cr. Hutchings was originally elected in 1953 and served continuously for a period of thirty years. The Board has seen fit to present Cr. Hutchings with a Life Governors certificate in recognition of his services to the hospital. The hospital Board join with the community in congratulating Cr. Hutchings on his receival of an M. B. E. This well deserved honour is in recognition of his devoted service to the Stawell Community of which his service to the hospital was a large part.

Mr, Sainsbury was originally elected in 1969 and served the hospital with distinction during his time of thirteen years. In that time Mr Sainsbury served two terms as hospital chairman.

The Board of Management was saddened by the recent passing of Mr. Les Erwin, a past Board member and President of the Hospital. We extend our deepest sympathy to Mrs Erwin and family. It is detailed later in our annual report that the hospital appointed Mr. Erwin a Life Governor of the Hospital shortly before his passing.

The Governor in Council appointed Mr. Graham Fuller and Mr. Robert Illig to the vacant positions created by Cr. Hutchings and Mr. Sainsbury's resignations. Both Mr. Fuller and Mr. Illig expand the professional expertise presently on the Board with their contribution proving immediate and beneficial in conducting the complex process of hospital affairs.

Three Board members attended a Board Member Education Seminar conducted by the Australian Hospital Association. These have proved most helpful to Board members and reflects all Board members attitude in their endeavours to be better informed in all aspects of hospital management.

DEVELOPMENT

Nursing Home

It is pleasing to report that the establishment of additional nursing home beds is very nearly a reality. The appropriate approvals have been obtained and the community have responded magnificently to a public appeal. It is sincerely hoped that the nursing home extension will be opened within twelve months.

Kitchen Redevelopment

The contract for the kitchen redevelopment has been let and it was pleasing that a local builder Mr. M. Kwiatek was the successful tenderer. This project is going to cost in the vicinity of \$366,000. This figure includes \$75,000 for new kitchen equipment. The present kitchen is fifty years old and very little money has been spent on it during the last 50 years. The quality and quantity of meals prepared from the kitchen with its present outdated facilities reflects highly on all staff in that area. Once the new kitchen is completed the hospital will have the capacity to cater for the expansion in our nursing home beds and we could, if requested, supply a meals on wheels service 7 days a week. Government grants totalling \$104,426 have been committed to the project and the balance of \$261,574 is to come from the hospitals capital fund.

It is gratifying to the board that the above two urgently needed projects will in all probability be completed during the next 12 months. Stage three of the modernization of the hospital is the upgrading of the hospital acute wards and our outpatient/theatre areas. The Health Commission, before they will consider plans for stage three are seeking from us a delineation of our role, that is, a statement of the medical services we wish to provide and to what level of complexity. Upon the finalization of this role statement, the hospital Board and the Health Commission will be better informed as to what major remodelling is required in light of the services to be provided.

WORKS AND EQUIPMENT

Utility Rooms

Several urgently needed renovations were carried out this year. The three hospital "utility" rooms were modernized and included in each was a pan sanitizer. The total cost of this project was \$17,027.

A government grant of \$15,000 was received for this project.

Pharmacy

A pharmacy storage and preparation area was established on the first floor of the hospital at a cost \$4,315. A government grant of \$3,365 was received for this project.

Replacement of Sterilizer

The hospital's main sterilizer was replaced during the year at a cost of \$18,392. A government grant of \$15,430 was received for this project.

RENOVATIONS

The first floor of the hospital was carpeted, curtains and evaporative cooling installed, two walls removed and this once not used area is now a hive of activity. Administration staff are accommodated along with the Pathology Laboratory now in this area. In addition the board room is located in this area.

The hospital now has an appropriate staff cafeteria in a refurbished portable classroom supplied by the Education Department and I am aware of just how grateful the staff are of this improvement.

Finally in the area of maintenance the committee approved of the supply and installation of both a "master key" system that will substantially improve security in and around the hospital and the installation of a comprehensive sign posting system.

STAFF

It has been said that an organization's greatest resource is its staff, and this is certainly true in this hospital's case.

During the year the following people were appointed to senior positions in the hospital: Mr. B. Fowkes, Director of Nursing; Dr. D Douglas, Medical Director; Miss S. Castle, Medical Record Administrator. (Both these last two positions being shared with Ararat Hospital). Mr. G Martin, Maintenance Foreman; Mrs. D. Dalby, Charge Sister Male Ward; Mr. I. Gill, Physiotherapist; Mrs. C. McLean, Theatre Charge Sister; Mrs. S. Veroude, Radiographer, and the hospital was fortunate to be granted two positions under the government's job creating schemes. Mr. S. Healy was appointed an apprentice carpenter and Miss C. Smith was appointed as a typist/receptionist, funding for the latter position only lasts 12 months.

After twenty-four years service to the hospital Mrs. Doris Evans retired. Mrs. Evans will always be remembered for her work in the Midwifery Ward of this hospital. The Board of Management have unanimously agreed to grant the hospital's highest honour to Mrs. Evans by appointing her a Life Governor of the hospital.

Mrs. Lola Hoare resigned after serving this hospital admirably as matron for many years during very difficult times. Mrs. M. Allan and Mr. H. Hunter also served the hospital well and resigned during the past year along with Miss D. Wallace and Mr. T. Vella.

To those who have left we extend our appreciation for the individual contributions made, and to all new staff we extend a very warm welcome and trust that your stay here is enjoyable.

Appointed to the consultant medical staff during the year were Dr. J. Hurley and Dr. R. House both of Ballarat. Dr. Hurley who is a qualified geriatrician was appointed by the Board to advise it in its care of elderly people and services required now and in the future. Dr. House replaced Dr. Wong Shee as the hospitals consultant radiologist.

APPRECIATION

The hospital auxiliaries, namely the Ladies Auxiliary and Younger Set have again been wonderful supporters to the hospital. The Ladies Auxiliary donated significant funds to provide new curtains for the midwifery block and the Younger Set donated a patient lifter which has been urgently required. In addition members from both the auxiliaries have arranged a roster to assist in the therapy of patients in the day hospital. This work is mainly involved in cooking activities and the hospital is appreciative, as the patients are, of their time spent in that area. The support of the Base Hospital at Horsham is often sought and readily received from the executive staff and the Committee of Management of Wimmera Base. We are deeply appreciative of their support and encouragement in providing access to their resources.

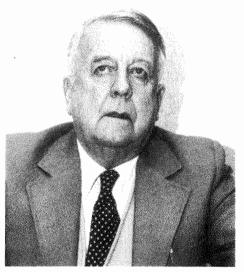
Vale - Mr. Leslie R. Erwin

REPORT OF THE MEDICAL DIRECTOR

In November of 1982 I commenced duties as the Medical Director of Stawell District Hospital. This is a new position and is a shared position with half my time being spent at Ararat and District Hospital where I am also the Medical Director.

Since taking up the post I have been asked on a number of occasions what is the role of a Medical Director and what are my duties. These are not easy questions to answer as the role and duties vary slightly from hospital to hospital. However, in a general sense the Medical Director represents the third arm of hospital administration and generally watches over and assists in the delivery of medical and medical ancillary services. The two other arms of hospital administration (nursing and general or financial) have been represented at Stawell for a number of years now by the Director of Nursing and Manager respectively.

Two important factors have been relevant in establishing the new post of Medical Director at Stawell at this time. The first of these factors is the cost of running modern hospitals. In 1972 the hospital admitted 1,242 patients and spent \$250,192. In 1982, 1,893 patients were admitted at a cost of \$2,279,807. These figures represent a growth in admissions of 4.3% per annum and a growth in expenditure of 24.7% per annum. One role of the medical administration is to attempt to control costs and increase efficiency.

The second and in my opinion more important factor, or reason relates to the complexity of modern medical services. The medical team has grown enormously over the last ten years and occupational therapists, welfare workers, physiotherapists, radiographers and pathology technologists, to name but a few, are all involved in even routine medical care today. One person needs to be responsible for ensuring all these people work together to aid the nursing staff and doctors in providing high quality and timely health care. The Medical Director has this duty of co-ordination. As in all complex operations, quality assurance is very important and this too, is part of the role of the Medical Director. The Medical Staff of the hospital have commenced a voluntary self assessment or peer review programme to ensure the maintenance of high medical standards. Other medical ancillary departments have also embarked on programmes of quality assurance. Thus despite the relative isolation of the hospital and the smallness of its departments, the people of Stawell have every reason to be confident in the professionalism of their hospital staff.

This is a brief outline of the role of the Medical Director. Since taking up my post in November there have been changes in some hospital departments in line with the new administrative structure of the hospital. These changes have been made to increase the breadth of medical care available in Stawell and to ensure that the present high quality of care is maintained. As all are aware, the aging of the population has placed an increasing burden on health and welfare services. The hospital has to respond in an imaginative and constructive way to these new demands and to seek to work with other care agencies towards the common goal of a better life for all.

It is my hope that, together with the Director of Nursing and the Manager I can play my part in providing first class health care for the people of Stawell and District.

VISITING MEDICAL OFFICERS ANNUAL REPORT

Over the last year the Visiting Medical Practitioners of the Stawell District Hospital have continued to hold their regular meetings on a monthly basis.

Mr. Keith L. Hayes continued as Chairman and Dr. V. Szewczuk as Secretary.

During the year we welcomed Dr. D. Douglas, the Medical Superintendent, into our ranks.

The past year saw the formation of an abundance of committees in the hospital and the Visiting Medical Officers were asked to supply representatives on these committees. Drs. R. N. Castle and V. Szewczuk became representatives on the Patient Care Advisory Committee, Mr. R. Warne on the Infection Control Committee, Mr. Keith L. Hayes and Dr. A. Cunningham on the Theatre Committee, and the chairman of the Visiting Medical Officer's group on the Medical Advisory Committee.

Some of the achievements of the group have been:

- the improvement of equipment available in the out-patient department of the Stawell District Hospital.
- (b) the ordering of a new anaesthetic machine for minor theatre.

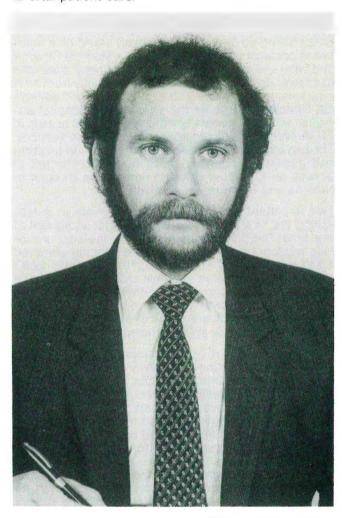
Dr. Mary Brown was invited to address the Visiting Medical Officers on the use of physiotherapy in the treatment of neonatal jaundice. As a result of this address a protocol is to be drawn up as a forerunner to the obtaining of our own phototherapy unit.

The year also saw the active opposition by the Visiting Medical Officer's group to the formation of a Family Planning Clinic by the Town Council in Stawell on the grounds that it was totally unneccessary and that the visiting Medical Officers provided an adequate service.

Peer review was also commenced and it was felt that this would only further improve the standard of care provided.

The Visiting Medical Officers welcome the new Director of Nursing, Mr. B. Fowkes, and look forward to liaising closely with him with the intent of improving communications between the medical and nursing staff.

In summary the past year has seen many changes and innovations which have improved our common goal. ie. total patient care.

DIRECTOR OF NURSING REPORT

SYSTEMS — Substantial progress has already been made towards fulfulling requirements for Accreditation in June 1984. These efforts must lead to continual improvement in patient care:

- The Nursing Practices Committee is engaged in the task of updating the Nursing Procedure Manual.
- (ii) The Nursing Education Committee is concerned with the provision of on-going education for all categories of nurses.
- (iii) The Quality Assurance Committee is engaged in sampling nursing care to ascertain the effectiveness of care given.

A Patient Dependency Program is being implemented whereby nursing workload can be objectively calculated on a daily basis.

STAFFING — The following senior appointments have been made during this year: Sister Jacqueline James — Acting Charge Sister for Midwifery; Sister Christine McLean — Charge Sister for Theatre; Sister Denise Dalby — Charge Sister for Male Ward.

These senior Sisters have already made a significant contribution in the areas in which they work. The willingness of all levels of staff to come on duty to replace sick staff and to attend educational activities in their own time is an indication of their dedication.

PHYSICAL FACILITIES — The renovation of utility rooms which has begun, will make working conditions more efficient for staff. The renovations to Midwifery and Female Ward Bathrooms will certainly result in increased patient comfort.

CO-OPERATION — The Nursing Service is grateful for the support and co-operation it has received from all

hospital personnel and Departments during the year. The contributions made to patient comfort by the Auxiliaries during the year were particularly appreciated.

ASSISTANT DIRECTOR OF NURSING REPORT

During the last twelve months, many new and exciting projects have been commenced within the nursing division. Probably the most important is the implementation of an on-going education programme to enhance the clinical expertise of our nursing staff whilst broadening their professional outlook, in an endeavour to maintain premium standards of patient care.

During the month of June, eighty-four attendances were recorded at these sessions and interest appears to be increasing. Many thanks for the success of this programme must be given to the Board of Management and the Nurses themselves. Firstly, it is the need for an education budget, by allocating funds specifically for this project during the 1982-83 financial year. Secondly, it is the nursing staff who attended in excess of eighty percent of these sessions in their own off-duty time.

Expenses this year have exceeded \$1000 in the purchasing of new educational equipment, whilst further expenditure in this area is anticipated next year.

The major training programmes that are currently being undertaken or have been completed, include:

- 1. Basic Cardio-Pulmonary Resuscitation Skills for all nursing staff,
- Extension of the basic skills attained in the General Nurse Training Curriculum for use of modern bedside electronic equipment, and
- Evaluation of current nursing practices with regards to the possible implementation of "problem-solving" patient care.

Several nursing committees are being formed in order to analyse patient care with the view to early recognition of current/potential deficiencies in the giving of patient care. Two such committees are co-ordinated by myself and they are, the Quality Assurance Committee, and the Educational Advisory Committee.

It is with anticipation that I look forward to what I am sure will be an even more rewarding twelve months.

SYME WARD & DAY CENTRE REPORT

The year 1982-83 has been a busy and challenging one. We have again functioned at maximum capacity, in fact over capacity for a few weeks with one extra bed being placed in our store room. This was due to a desperate situation necessitating the admission of a patient to our already fully occupied ward.

The nursing care given to all patients in this area has continued to be of a high standard.

We all look forward with much interest to the building of the new wing which will add a further eleven beds to Syme Ward. It has been interesting being involved in the planning of this new area, and much thought and concern has been shown by our small committee.

Last October saw the continuing of the Day Centre and Syme Ward. This has been of great benefit to patients of Syme Ward, a number of whom attend the centre daily and are therefore able to communicate with others from the outside community. They also participate in all mental stimulation activities and craft work and now have a new interest in life. Use of the Day Centre by patients from the acute area, nursing home and community has increased 100% over the past twelve months.

As I write this report, the bathrooms in Syme Ward are being updated with the removal of tiles in the shower recesses and the application of vinyl to the walls and floors. We have also had an additional toilet installed.

The patients from the Day Centre and Syme Ward have been on a number of outings during the year. These outings included a glass blowing demonstration, a tour of the gold mining area, afternoon tea in the mall, a visit to the World in Miniature and a concert organised by the Combined Pensioners.

The lives of the elderly have been enriched through people providing time, entertainment and other services.

My staff and I would like to thank all who have assisted.

DISTRICT NURSING SERVICE REPORT

Over the past twelve months, the District Nursing Service has made approximately 5000 visits, providing 20,000 varied services to people cared for at home.

This service allows patients to be discharged from hospital earlier, cared for at home longer and in some

cases kept out of hospital altogether, thus enabling hospital beds to be kept for the more Acute patients.

PHYSIOTHERAPY ANNUAL REPORT

It took only a short time, after commencing employment here in January 1983, to realize that the Physiotherapy Department was a very busy one.

In the first three months of 1983 I was fortunate to have an experienced therapist, in Miss Donna Wallace, sharing the department workload. Such an opportunity enabled a smooth transition to the role of sole Physiotherapist.

The assistance of a Physiotherapy Aide, namely Mrs Marie Cray, has proved immensely helpful to the efficient functioning of the department.

Since July 1982 the Physiotherapy Department has treated 1,160 patients. The total number of treatments for this 12 month period was 5,799. Of this number 3,221 were outpatients and 2,578 inpatients.

The department is involved with the treatment of acute inpatients, rehabilitation, outpatients and Syme Ward patients.

Rehabilitation ranges from anything such as stroke or amputee work to the mobilization of people following fractures.

In Syme Ward the department aims to optimize the functional independence of residents.

Already this year, the department has participated in nursing education. The subject of low back pain and injury was discussed with all nursing staff and techniques of safe patient lifting were demonstrated.

The department will continue such education in the future and the contribution to nursing education will grow.

This year has seen the addition of an extra treatment cubicle to the department which greatly benefits the efficiency of outpatient treatment.

A waiting area has been set aside in the foyer of the Day Centre which eases congestion inside the department.

The addition of practice steps and a storage cupboard are planned for 1983.

Specialized physiotherapeutic services have been and continue to be utilized by the department. In particular the Queen Elizabeth Hospital Amputee section

has been a very helpful service to several Stawell Hospital patients. By working with such a service the optimal rehabilitative potential can be realized for Stawell patients.

Within a healthy environment of inter-departmental communication and co-operation the Physiotherapy Department will continue to offer a valuable service to the people of Stawell.

DEPARTMENT OF RADIOLOGY

The past year for the X-Ray Department has been one of significant change and advancement with continued improvement for the coming year.

A new cassette/screen and film combination introduced 12 months ago, has resulted in excellent quality radiographs, with increased density and contrast latitudes, at half the radiation dose previously used in the old system. A secondary benefit of the system is that the film is cheaper to purchase. At the moment we have only a very basic set-up with a minimum number of cassettes, but as there are further cassette/film/screen combinations available for specific examinations e.g (very high detail for examination of extremities), we hope to expand our range in the near future.

The first full-time Radiographer commenced duties on 13th October 1982. Prior to this a once-weekly service was offered from Horsham, with obvious inconveniences.

The department offers a normal five day service, plus emergency after hours. By working in conjunction with Ararat District Hospital, alternate weekends off are possible, with one Radiographer being On-Call for Ararat and Stawell on weekends. This co-operation with weekend On-Call has been working satisfactorily since mid-April 1983.

Patient attendances have risen steadily over the past year, especially since October 1982, and further increases are expected due to expansion of examinations performed.

Dr. L. Wong Shee, Horsham, ended his term as Consultant Radiologist on June 30, 1983, and we thank him for his years of service.

Dr. R. J. House, Ballarat, is now the Hospital Consultant Radiologist, and will visit monthly to ensure smooth running of the Department.

PATHOLOGY REPORT

The past twelve months have been busy for pathology. The Department has been relocated to its new premises on the first floor of the Hospital, and the better conditions are much more pleasant to work in.

The main concern, when relocation upstairs was finalized, was that the elderly and incapacitated may have had trouble attending the department for tests. This has caused no problems since patients who cannot climb the stairs are seen downstairs.

The extra amount of space available in the new laboratory has enabled the department to purchase more equipment to provide a more efficient service. The Pathology Department has purchased three main items during the past year.

- 1. 1 34 cubic foot Refrigerator.
- 1 Chemetrics II Analyzer.
- 1 Beckman Electrolyte 2 Analyzer.

The total cost for these three items was in excess of \$35,000. Items 2 and 3 have enabled the laboratory to become much more efficient. Automation has resulted in the Department being able to consider an expansion of services.

During the past year, a total of 3,303 patients were referred to the department (compared with 2,860 for the previous year), for a total of 21,755 tests (compared with 17,029 for the previous year).

The number of blood donations collected by the Stawell Red Cross Ladies in the past twelve months, was 547 (compared with 605 for the previous year). Blood not used for transfusions was sent to Central Red Cross Blood Bank for fractionation into different components.

A 'Pathology On-Call Service' is provided in conjunction with the Pathology Department at Ararat & District Hospital, and when the Pathology Technologist is away, Ararat Hospital Pathology provide a service for Pathology requests.

MEDICAL RECORDS DEPARTMENT REPORT

The Medical Records Department has undergone a few changes over the past 12 months. Mrs E. de Fegely left the Hospital in September '82 and Miss Stephanie Castle resumed the role of Medical Records Administrator in November '82.

The main role of the Medical Records Administrator is to collect and collate morbidity statistics which are then sent to the Health Commission and the Australian Bureau of Statistics.

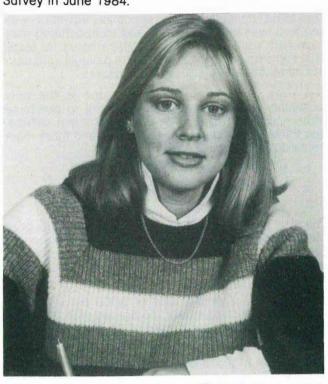
The Diagnosis & Operations of all patients discharged are coded, using an International Classification System. The codes are put into the Hospital Computer Terminal and transmitted to Monash University Health Computing Service. This service stores all the transmitted data in memory banks, where the data is collated and sent back to the Hospital in the various report format that the Hospital requests. The Reports received are used by the Hospital for statistical reports, medical research, patient care evaluation and medical facility planning.

At the end of each financial year, all of the Operations and Diagnoses for the Hospital are cross-indexed by H. C. S. and sent back to the Hospital.

Other roles include maintaining strict control over the Medical Records, ensuring that all recorded clinical information is thorough and accurate, processing legal correspondence, preparing reports, designing medical record forms and attending seminars and regional meetings.

Within the next two months the Medical Records Department will be relocated to ground floor. This will be a more central position and will make the department easily accessible to authorized staff.

The next twelve months will be aimed at dramatically improving the whole medical record concept within the Hospital in preparation for the Accreditation Survey in June 1984.

PODIATRY REPORT

Podiatry-Chiropody Services have been available at the Stawell Hospital for some years now although it was only in the past eighteen months that it has been introduced as a sessional hospital service. It provides a service for Hospital patients, Syme Ward, Geriatric residents, Day Centre patients and Outpatients from the surrounding areas.

During the past twelve months the number of patients treated has increased considerably. From an average of eighteen patients per session to an average of fifty patients per session in June 1983, therefore the number of sessional hours has been extended to three working days per month.

The age group attending the podiatrist are mainly elderly although there has been a recent increase in younger people who play a lot of sport and children.

This year has seen the podiatry services well utilised and there is every indication that it will continue to grow in the future.

 - (iii) Income from short term investment of Operating funds has been credited directly to the Capital account.
 - (iv) Income from investments has not been brought to account in determining the year's operating result. This is consistent with prior years.
- (f) Stock on Hand

Stocks on hand include all stores held in the General Store and Pharmacy. Stocks on hand are valued at latest purchase price which is consistent with prior years.

Variation in stock levels has been brought to account in the year's operating result.

STAWELL AND DISTRICT ELDERLY PEOPLE'S HOME SOCIETY

The society was formed in 1981, and adopted as part of its' By-Laws, the objects of raising funds for, and the construction of, a nursing home extension on to our existing Syme Ward wing. This extension is to provide nursing home care and accommodation for those persons falling within the categories defined under the Aged and Disabled Persons Homes Act.

It was necessary to form a completely separate committee from the Stawell District Hospital committee as no state government funded organization is eligible for grants from the Commonwealth Department of Social Security.

The provisional committee, which will remain in office until the objects of the society have been realized, has appointed three trustees to hold the assets of the society in trust. The Health Commission registered the society as a benevolent society under the provisions of the Hospitals and Charities Act 1958.

The society advised the Commonwealth Department of Health of its registration and subsequently received advice from that department that when the eleven bed extension was built, the Commonwealth would pay nursing home benefits on the extra eleven beds (presently \$41.90 per day).

During January 1983 the Commonwealth Department of Social Security announced that it would provide the maximum allowable grant to the society of \$14,000 per bed, to assist in the construction of an extra eleven nursing home beds in Stawell.

It is estimated that the nursing home extension is going to cost \$454,000. Therefore it meant that the community had to raise \$300,000 as its share.

It is history now that the community responded magnificently to the appeal. In a nine-week intensive phase \$390,070 was pledged to the society over a

three year period. It was gratifying to the committee that firstly Cr. K. Haymes accepted Chairmanship of the appeal and that the community responded so generously so that our frail aged in urgent need of nursing home care may stay in the district rather than be sent to distant institutions.

It would be remiss of me if on behalf of my committee, I did not thank the many public organizations who have pledged significant amounts to the appeal over a three year period. We appreciate the magnitude of the commitment these committees have made and we wish them every success with their fund raising ventures.

Included in this report is a list of some of the donations and pledges made to our appeal. In addition a further four hundred and fifty pledges and donations were made.

The Department of Social Security, before they will allow tenders to be called for our building extension insist that 90% of the estimated cost must be "in hand". In our case we must have \$250,000 "in hand". It is anticipated that we will have this amount by September 1984 based on payment dates specified in pledges to the appeal.

It is the earnest desire of the society that the extension is opened during the 1984 calendar year. In the meantime my committee will be negotiating with appropriate authorities to allow further nursing home beds to be established in Stawell, over and above the eleven bed extension already approved to allow this community's aged people access to facilities comparable to other such communities in the State of Victoria.

REPORTS

FOOD SERVICE DEPARTMENT

The past year has meant a time of continuing change to the Food Service Department. In September last year we changed the menu's to allow some more flexibility for our special diets and to give a greater choice of food to the patients and staff of the hospital. A meal survey placed through the hospital during the month of May 1983 showed that most of the patients enjoyed the meals and the choice of which they were given.

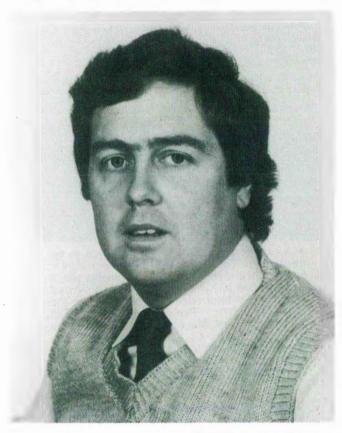
Occasionally through the year we were able to cater for special functions for guests to the hospital. These functions have enabled the cooks to widen their knowledge of cooking. On occasions it has been necessary to approach the Younger Set and ask for their assistance on a voluntary basis. The Younger Set have always answered our call for which I would like to thank them for their time in helping us. It has always been greatly appreciated.

Two new pieces of equipment have been functioning in the kitchen for almost 12 months, these being a dough brake and a walk-in freezer. Both have proved to be of great value to the food service staff with storage and time savings on the work load.

During the month of June 1983 the cafeteria as eventually opened. The staff, now have a better environment to eat and sit during their breaks. The cafeteria has also provided a better service for providing staff meals.

The plans for the new kitchen have now been completed and are at present in the hands of the Health Commission. Hopefully building will commence during the later part of 1983. While the kitchen is being built, a temporary building has been obtained to allow the staff to provide meals, for the patients and staff, with minimal inconvenience.

It has been a busy year for the food service staff and I would like to thank them all for their good work and continuing effort for trying to provide a good service to the staff and patients of this hospital.

SAFETY REPORT

Safety needs and awareness in Industry and Hospitals is something that is becoming very apparent. The cost of Workers' Compensation to the Health Commission is astronomical. Although safety is an expensive commodity to ensure in Hospitals, it is even more expensive to pursue Workers' Compensation Claims.

During April '83 I attended a one week training course on Safety at the Mayfield Centre, Malvern. The aim of this course was to educate us in safety awareness and how to prevent accidents.

The staff have now been educated in correct lifting techniques to prevent back injuries, and electrical attachments are being checked in order to prevent electrical shocks and burns.

Safety surveys were carried out in most of the Hospital departments, in which each departmental head was made responsible to check various items for safety status. If an item was in an unsatisfactory con-

dition an explanation was sought and that department was responsible for making that item safe.

A fire-plan has been designed. If the fire alarm is raised, each person has been given a specific task and allocated to a specific area.

The C. F. A. has been a great help to us with our fire plan and safety training, and I would like to thank them for their assistance.

Next year we hope to have an internal disaster plan made up, and we are also co-ordinating with the S. E. S. and other emergency groups in making up an external disaster plan.

DOMESTIC SERVICE REPORT

A group of workers who are quite often forgotten in the Hospital, the Domestics, play a vital role in Infection Control.

Stainless steel mop buckets and handles are used in most parts of the Hospital. These buckets are easier to keep clean, especially where there is no rust present. The buckets have a longer life span, this saving the Hospital money in the long term.

I would like to thank all the Domestic staff for their assistance during the year, and hope that next year continues to be an even better year.

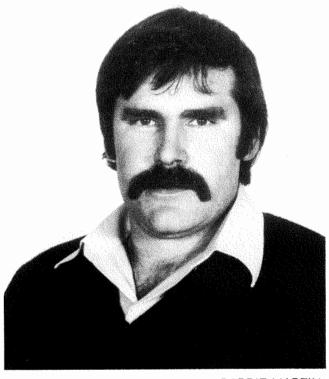
New projects started are the much needed renovations to bathrooms in Syme Ward and Midwifery Wards.

In conclusion I would like to thank Management, Nursing Staff and Maintenance Staff for their support and co-operation since I started work here.



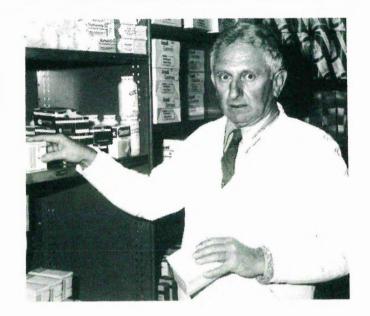

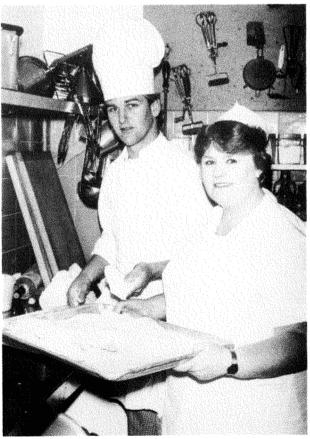
