BOARD OF MANAGEMENT REPORT

As chairman of the Board of Management it is my privilege to present the 128th Annual Report together with the audited statements of accounts for the year ended June 30, 1987.

At the commencement of this report it is appropriate that we review our progress towards achieving the objectives foreshadowed in last years report:

Expansion of para-medical staffing levels

Whilst this objective has not been achieved we are pleased to report our staffing levels in this area have not diminished. In March we were delighted to receive the services of Ms T. Kelly Audiologist from Wimmera Base Hospital who visits this hospital approximately every two weeks. In conjunction with Ararat Hospital we expect to appoint a Speech Pathologist in January 1988. We are currently seeking to allocate a bursary to a final year physiotherapy student with the view of the successful applicant also commencing in January 1988.

Commissioning of new twenty-four bed **Medical Ward**

Some delays did occur however patients occupied the new ward on August 24, 1987.

Computerization of Pathology and Radiology accounts.

Implemented September 1, 1987 with significant benefits resulting in the raising and collecting of fees.

Air conditioning of Syme and Perry Nursing Home Wings.

This project was completed in February 1987 at a total cost of \$64,682. The hospital and the nursing home were fortunate to receive a government grant totalling \$51,000 towards the cost of this project.

Upgrading of radiology services and equipment

With the tripartite support of our consultant Radiologist, local Medical Officers and the Victorian Government we achieved this objective.

In December 1986 the Government announced that it had made available \$307,000 to replace our existing x-ray equipment and provide new equipment to expand our services. In addition our consultant Radiologist located one of their ultrasound units at this hospital with the result that on average, twelve ultrasound tests are done at this hospital each week. This service is provided at no cost to the hospital and clients are saved from travelling to other distant centres.

Seek to provide more Specialist Medical Services.

Again this objective has been met by the appointment of the following Specialists:

We are extremely grateful to these specialists who have agreed to visit this community and we acknowledge the assistance of our local Medical Officers and Dr Scaife in bringing about these appointments.

HIGHLIGHTS

The two major highlights of the year were:

- The official opening and occupation of the new twenty-four bed medical ward
- 2) The upgrading of our Radiology Department as detailed previously.

In March the Board invited the Stawell community to suggest names for the new wing. The overwhelming response from the public was that the new wing should be named in honour of Dr Norman Castle. The Board agreed to this course of action in recognition of Dr Castles' service to the hospital for the last thirty-two years.

While Dr Castle is a senior partner in his private medical practice which provides an excellent service to the town and district, he has committed an enormous amount of his time to instigate change at the hospital especially during the past seven years since his appointment to the Hospital Board.

In addition to his major involvement with this hospital Dr Castle has been extensively involved with other organisations in the community.

The Hospital Board, on behalf of the community of Stawell is delighted to permanently acknowledge Dr Castle's contribution by naming the new wing the "Dr Norman Castle Medical Wing"

The wing is now occupied and I am sure the staff and patients are pleased with the new facilities. The Board is appreciative of all staff's contribution and planning of the Castle Wing and the quality of workmanship in its establishment provided by the major contractor Cody and Quinn Pty Ltd. All this would not have been possible without the support of the Victorian Government which provided \$1.5m towards its total cost of \$1.6m. Special mention is made of our maintenance staff who landscaped what is a very difficult

throughout the year. To my predecessor Mr John Bennett we acknowledge your fine year as chairman of the Board. Unfortunately during the year Mr Bennett was one of three Board members who resigned from the Board, the other two members being Mr G. Hall and Mrs F. Holden.

To those past Board members we say thank you for your contribution to this hospital. During the year the Minister of Health reappointed Mr Stone and Mrs Blake for further terms and made a new appointment of Mrs J Brilliant to the Board.

HOSPITAL DEVELOPMENT

During the year the Board with the support of the Health Department clarified its forward plans for the redevelopment of the Hospital.

Finalisation of the hospitals redevelopment plans was made substantially easier with the professional advice received from the hospitals new architect Balcombe Griffiths Pty. Ltd. who was appointed in December.

In summary the redevelopment plan for this hospital is:

- (a) Dr Norman Castle 24 bed Medical Wing.Occupied August 24, 1987. Cost \$1.6m.
- (b) Redevelop 16 bed combined Midwifery/ Surgical Ward plus the establishment of new front entrance to hospital building.
 It is hoped that building will commence

on this stage in April 1988. Estimated cost \$2.5m.

(c) The third and final stage involves the establishment of new facilities for:
Accident and Emergency, Operating Theatre, Central Sterile Department, Radiology, Pathology, Maintenance Workshop and Staff Cafeteria. The Board has submitted this proposal to the Health Department requesting that it be included on future design list programmes. This stage cannot be expected to commence inside the next 3-4 years, however, the Board is hopeful of receiving funds to allow planning and design work to proceed. Estimated cost at today's prices is \$3.5m.

The Hospital Board is pleased with what has been achieved to date in the redevelopment of the hospital and is hopeful that this much needed development will continue.

STAFF

The Board is pleased to report that the year under review is highlighted by the minimal number of staff resignations received.

Mrs A. Wheatland, Unit Nursing Manager of our Medical Ward resigned in January. It is always disappointing to lose staff of Mrs Wheatland's calibre, however we were fortunate to be able to promote Mrs J. Kayler-Thomson to the vacancy created.

Ms K. Henry our Medical Record Administrator resigned her position in February. Ms Henry was a vibrant contributor to the Hospital and we were sad to see her depart, however we wish her well in her new appointment at the Nhill Hospital. Ms Henry was replaced by Ms K. Douglas who we welcome to our staff.

Two new Visiting Medical Officers were appointed during the year. Dr M. Vawser commenced with Dr Gregg in the Victoria Street Clinic and Dr G. O'Brien worked from the Wimmera Street Clinic under the Family Medicine Programme.

One of our physiotherapist's Mr P. Steggall was granted rights to private practice during the year. This arrangement allows Mr Steggall to consult patients who are able and willing to pay for consultation outside normal department hours. This arrangement appears to be operating to the mutual benefit of both clients and the hospital as the waiting time for an appointment with the physiotherapy department has been significantly reduced.

All the hospital was saddened by the death, as a result of accident, of our apprentice gardener Mr Bill Darling in September. Bill impressed everyone with his sincerity in the short time he was with us and his death was a tragic loss of life.

In the latter part of the year we welcomed Mr R. Hemley back to the hospital after a seven year break to the position of Administrative Officer.

FINANCE AND STATISTICS

Our operating cash payments for the year under review amounted to \$4.4m. This amount includes operating costs of our 30 bed nursing home complex.

It is pleasing to again report that we have completed the year with our expenditure equal to the budget as specified by the Health Department. All staff are to be commended on this result which reflects on their prudent use of recources.

The hospitals activity during the year based on bed days and patients treated increased substantially over the previous year.

The number of bed days in the hospital section increased from 10,580 to 10,854. An increase of 2.6%. The number of patients treated increased from 1,446 to 1,681 an increase of 16.3%.

Our average length of stay dropped from

7.3 days down to 6.5 days. The average daily occupancy in the hospital being 78.3%.

In our nursing home the increase in activity was even more pronounced: Bed days increased from 8,255 to 10,920 i.e. an increase of 32.3% with a percentage occupancy of 99.7.

A detailed report of the Hospitals financial and statistical information is provided later in this report.

EXPANSION OF SERVICES

In recognition of the need to plan for the future to ensure this hospital continues to meet our communities expectation, a special sub-committee of the Board was appointed. This committee comprised all disciplines of staff and had, as its terms of reference, to develop methods and strategies by which services at this hospital could be expanded. The committee produced a plan broken up into health services that should be provided immediately, over a five year plan and over a seven year plan.

The appointment of visiting specialist detailed earlier is one of the immediate results of this important committee's endeavours.

This committee will continue to meet to explore ways of establishing new and innovative health services at this hospital.

In concluding this report I would like to express our appreciation to this hospitals greatest asset - its staff. All our staff are dedicated to their work and strive to increase the excellent quality of patient care we are able to provide.

Mr Paul F Gross, who is presently Director of the Institute of Health Economics and Technology Assessment in Sydney, which he formed in May 1980.

The Institute is an independent think-tank for policy research and education, supported by both private sector grants and research grants, contracts from Federal and State Governments, and contracts from international organisations.

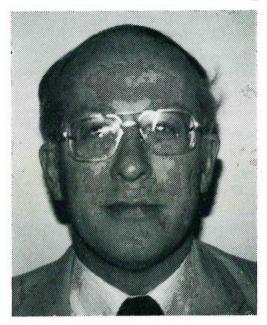
Mr Gross has formal qualifications in civil Engineering (University of Sydney, 1960) and a Master's degree in Industrial Engineering (University of NSW, 1967). He specialised in economics and policy analysis at the Woodrow Wilson School at Princeton University, where he obtained his MPA in 1971

In the period 1972 - 1980, he held senior positions in both the New South Wales and Commonwealth Governments. He has been Director, Planning and Research at the NSW Health Commission, Commissioner and Acting Deputy Chairman of the Hospitals and Health Services Commission, and Special Adviser in the Social Welfare Policy, Secretariat, Canberra.

Mr Gross has had international experience as a consultant and adviser to national health authorities in five nations in the period 1970-1986, and was an adviser to the Royal Commission on Australian Government Administration in 1975.

He has recently accepted the invitation by the Government of Pakistan to carry out an extensive review of the nation's health financing system, and he is also a consultant to the Asian Development Bank and The World Health Organisation.

In 1979 Mr Gross was Australia's first guest scholar at the Brookings Institution in Washington, and is a member of the Board of Mt Druitt Hospital, Sydney. He is an adviser to four major religious orders involved in public and private health care.

Mr Gross is a member of the National Health Technology Advisory Panel, and is on the Editorial Board of the International Journal of Technology Assessment in Health Care, published by Cambridge University Press.

Finally, Mr Gross is an advisor to major corporations now developing private health care facilities using equity financing, and publicly listed companies as financing vehicles, including two proposals to develop private hospitals next to teaching hospitals. We are indeed fortunate to have such a distinguished administrator and specialist in the health industry as our guest speaker.

NURSING DIVISION ANNUAL REPORT

It is exciting to belong to a dynamic institution. As we approach the end of this year the prospect of occupying a completely new 24 bed medical ward, with every modern facility for patients and staff is a prospect which is both exciting and challenging.

Nursing staff have also been actively involved in the next stage of our building programme planning, a combined 16 bed surgical and midwifery unit. I thank all staff for their input, their constructive comments and their suggestions. These have been incorporated where possible and will lead to a better work flow when this second stage

The air conditioning of the nursing home and the completion of the outdoor surrounds of this wing will certainly improve the quality of life for the residents there.

The programme of equipment acquisition has seen the purchase of ambulatory cardiac telemetry monitoring, pulse oximeters, and continuous blood pressure monitoring, for sick patients. The acquisition of this equipment will certainly enhance the care of sick or post-operative patients.

An increasing number of staff are engaged in post-graduate nursing courses, and this augers well for the future as we pursue our divisional objective of quality patient care.

The nursing division is happy to be able to provide work experience for secondary school students with a desire to see for themselves what nursing involves.

A substantial increase in the demand for nursing care in the home has meant that our district nursing resources have been severely stretched during this year. A record 116 births this year have kept the Midwifery Staff delightfully busy.



The increasing medical services of minor orthopaedic surgery, ophthalmology, cardiac physician and ultra-sound have been warmly welcomed by our clients, as travelling to other health facilities is now unnecessary.

I express my appreciation for the dedication of nursing staff in maintaining patient care levels during the Registered Nurse industrial

I acknowledge the valuable contribution of the Deputy Director of Nursing, Hospital Nursing Supervisors, Unit Nursing Managers and all levels of nursing staff in their respective roles. Particular thanks to Mrs J. Cornish, Chief Pharmacist and Mrs P. Marshman, Dietician, for their valuable contribution to our continuing education programme, and to the Medical Staff for their support and co-operation.

MEDICAL DIRECTOR'S REPORT

All who follow the news will know that hospitals are being constantly pressured by government to become more efficient, in other words, to treat more people for less money.

In the year under review Stawell hospital treated an additional 235 patients, an increase of 16% over the previous year but used only 2.6% more bed days, a situation produced by reducing the average length of stay by 11% from 7.3 days to 6.5 days.

The hospital also increased the range of specialist medical services available by appointing a number of highly qualified specialists as Visiting Consultants who visit Stawell on a regular basis.

The hospital appreciates the support of the local medical practitioners who initiated and encouraged the development of these specialist services.

New x-ray equipment valued at over \$300,000 is currently being installed at the hospital, increasing the range of examinations possible and enabling some procedures to be conducted with improved levels of safety.

A regular ultrasound service has been introduced by the hospitals Visiting Radiologist Dr Bob House who has provided the excellent equipment to commence this service in our hospital.

The various allied health professional services continue to function at an excellent standard and each department has provided its own report. All have worked extremely hard throughout the year and are to be congratulated on their efforts.

The hospital is looking forward to moving into the new "Dr Norman Castle" Wing, to a continuation of our building programme and to another year serving the people of Stawell and District.

VISITING MEDICAL OFFICERS' REPORT

The last twelve months has been a good one in the medical field, and it has seen the commencement of visiting consultant services in a number of disciplines.

Firstly we have acquired a visit from a Physician who specialises in Cardiology visiting the Stawell Medical Centre, but who also visits patients in the hospital and performs stress E.C.G. testing. We also have acquired the services of a Consultant Psychiatrist, Consultant Orthopaedic Surgeon, and have regular visits now from a Consultant Paediatrician and visiting Ophthalmologist.

We have also secured the services of another visiting Physician who specialises in gastro-enterology, and who is now performing endoscopies at the Stawell Hospital.

Physician and Cardiologist Dr John Stickland Consultant Psychiatrist. Dr Tom Stephens Orthopaedic Surgeon . Dr John Nelson Paediatrician Dr Mary Brown Physician

(Gastro-enterologist). Dr Ambikapathy Rheumatologist. . . . Dr K. Boyden (who visits four times a year)

There has been an improvement in the monitoring equipment at the Hospital during the last twelve months, and the medical staff are very appreciative of the excellent work that has been done by our Director of Nursing Mr Bruce Fowkes.

The doctors continue with their ongoing medical education and not only in the hospital in association with Ararat, but also a number of the doctors have been away to courses in Obstetrics and General Medicine and Surgery, so that the doctors generally are maintaining a constant update with recent advances.

Generally the year has been a harmonious one, and difficulties that have arisen have been fairly quickly settled and we believe that our Medical Director is helping quite a lot. We are also very appreciative of the quality of nursing that exists in our hospital, and the doctors enjoy a very harmonious relationship with our excellent nursing staff. We also are thankful for the good service rendered by our physiotherapists, our radiographer who is very helpful and cooperative, and also our pathology service which we must at all cost retain. All in all, I believe we are very fortunate in Stawell with the quality of our ancilliary services and the nursing care, and the Board of Management is to be complimented on their ongoing efforts to ensure that the highest quality of medical care is delivered to the people of Stawell and the doctors are right behind their efforts to do this.

PATHOLOGY

MEDICAL RECORD DEPARTMENT

It was my pleasure to join the staff of the Stawell District Hospital in February 1987 following the resignation and subsequent overseas departure of Miss Kaye Henry.

The Medical Record Department has processed a total of 1,654 inpatient records, an increase on last years total of 1,417. Statistics produced from these figures are used for future planning and possible funding of the hospital.

Since February 1987, we have seen the introduction of typed operation reports. The doctors dictate the operation notes onto a small cassette at the end of each operation. I collect the cassette from theatre and type the reports. This has been a great improvement in the Medical Record field.

The Medical Record Department continues to play an important role in providing data for hospital audits. Studies that have been completed include: the age range of patients admitted to the nursing home; the number of the different types of mental conditions treated at this hospital; and the number of patients treated for heart conditions within different age groups. It is because of the audits that the information recorded in the medical record must be accurate and have complete clinical documentation. Regular Quality Assurance studies is one way of ensuring this outcome.

Next year I look forward to becoming more involved in the hospital. I hope to expand the Quality Assurance Programme in the Medical Record Department, thus helping to maintain a useful and effective medical record that can only enhance the quality of patient care.

to cover these costs. I thank another volunteer, Harry Hunter for his prompt and skilled work in the installation of much of this equipment.

Two Arthritis Self Help Courses have been run between the Stawell and Ararat District Hospitals and support groups now meet regularly in each town.

The Community Health Programmes of "Healthy Lifestyle Holidays" and "Fun and Fitness" exercises in the heated pool have been well attended by the "over 50's" and have contributed to an increased fitness and feeling of well being of many. As a member of the Community Health Board I have been involved in the ever expanding directions in which the programs continue to develop.

Several work experience students interested in the career of Occupational Therapy have visited from the Stawell Secondary College and I have attended and hosted regional Occupational Therapy meetings throughout the year.

In conclusion I wish to thank all the hospital and medical staff for their co-operation, support and teamwork during the year.

RADIOLOGY

As you can see the number of people lucky enough to have an x-ray in the last year, has increased slightly. But the departments cost has gone up again while the fees raised have dropped. What does it all mean?

New equipment for the Radiology Department has arrived by the boatload! In recent weeks the hospital has taken delivery of a new mobile x-ray unit - a Siemens Polymobil; a mobile image intensifier - a Medecon SM6, which will greatly increase the versatility of the department, especially in the operating theatre. The processor which was mentioned in last years report did arrive and the quality of the radiographs taken has improved, being given that extra sparkle!

Within the coming months the Radiology Department hopes to move to a new location in the hospital. This relocated department will have brand, spanking new equipment (hooray, hooray) for the radiographer to play with! The equipment comes from Medecon and includes a screening tube and table (for barium studies etc.), a tomographic attachment, an increased output x-ray tube and a computer-based exposure programme. It won't play space invaders but the variety and quality of examinations performed will be increased.

The ultrasound machine also appeared and now there are many homes in Stawell and surrounding districts, where the first picture of baby in the photo album was taken before they were born. We took delivery of a new typewriter, as well, which makes the radiographer's life a little easier.

Other than that, the Radiology Department functioned in its usual efficient manner, which it will continue to do in the following twelve months.

PHARMACY

From July 1986 to June 1987 the Pharmacy supplied 16,935 items, an increase of 8% over the previous twelve months. This was due to a 16% increase in the number of inpatients treated at the Hospital. Despite this, non-salary pharmacy costs fell by 8% compared with the previous year (which in turn was 4% less than the preceding year). This decrease was due in part to a special collective purchase of pharmaceuticals and to the policy of purchasing minimum quantities of drugs so ensuring a high turnover of stock. This is important because few manufacturers will now give credit for expired stock. The reduction in purchases coupled with an increase in supply is reflected by a 15% decrease in the annual stocktake value. Pharmacy stock level is now considered close to optimal.

It will be increasingly difficult to contain costs in the coming year because of the prescribing of newer, more effective and very much more expensive drugs. For example, costs per patient per day are increased 3-4 fold when Augmentin is prescribed as an antibiotic instead of Amoxil 250mg. Similarly, in the treatment of hypertension, treatment with Renitec and Capoten costs 2-3 times more than with Adalat which in turn costs twice as much as therapy with Isoptin, Aldomet and beta blockers such as Tenormin, Betaloc and Inderal.

During the year several lectures were given to Registered Nurses on topics such as Antacids, Aspirin Bronchodilators, Cytotoxic Drugs, Renitec and Capoten. The interest these aroused was very rewarding.

About two years ago problems with Eric's health began and two blackouts sent him in search

He had been an active man all his life and the firess made him so weak he could barely move about.

Since his dialysis treatment began and he rec-ognises it is a terrific tic, he is feeling much better and far more cheerful.

The major reason for a dialysis machine being made available to Eric is that its use is a team effort, and without Isabel he would have to have the help of a specially trained nurse.

"When you take the cost of a machine. \$15,000, and \$30,000 a year to run it, you can see why the learning school in Melbourne was set up. 1 suppose it is of some benefit to the hospital to have the machine here, as without their cooperation it would have had to be set up at home. We went into that and found the hospital was the best place." he said.

Ultrasound- a different way of seeing inside

Most people, have had at some time in their life, an xray.

Although xrays do give useful information, they are mostly useful for the dense structures such as bones.

They are also useful for some soft organs such as lung, bowel, kidney and gall bladder, particularly if these organs have had special dyes introduced into them before the xray.

Ultrasound works on an entitrely different principle, which makes it partructarly suitable for seeing the image of soft organs.

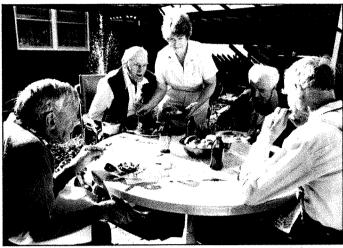

X-RAY UPGRADE FOR HOSPITAL

Stawell District Hospital a its monthly Board meeting, received advice from the Regional Director, that the hospital had been allocated \$307,000 to upgrade its x-ray equipment and expand its x-ray services.

Mr David McCracken, President of the Hos-oital Board, said that the Board was delighted to receive this grant, which is the result of a jumission by the Board in November 1984 to the Health Department.

Over recent months the range of services and facilites offered at the Stawell District Hospital have changed dramatically and in a lead up to the Hospital's new Castle Wing opening on August 24, the Hospital will be telling the public of Stawell of these services and facilities.

A series of articles will be published in the Times News to relate these services and facilities to the public.

The first of these is the Hospital's District Nurse Service.

Each morning at 7.45, two District Nurses make a complete check of their vehicles and supplies and depart from the Hospital.

and depart from the Hospital.

In the course of their day they will visit between 12 and 18 clients in their homes, and provide a variety of nursing skills.

Clients who have recently been discharged from Hospital may require assistance with small wound dressings, or on-going advice. Six diabetic clients will require life-maintaining insulin injections half an hour before they have their breakfast.

Some frail elderly clients who prefer to remain at home will be assisted with bathing and shower-ing. Where elderly clients are being cared for hy relatives the District Nurse will act as an advisor and supporter

It is a sad fact that terminal illnesses occur in our community. The District Nurse is there also, to provide nursing care to enable the client to remain at home, providing nursing and support appropriate to the clients needs.

The District Nurse may travel as far afield as Halls Gap, Glenorchy or Dadswells Bridge.

District Nursing Services are available to any sick person where that person's doctor considers the person ismost appropriately nursed at home.

STAWELL DISTRICT HOSPITAL STATEMENT OF ACCOUNTING POLICIES

The accounting policies of this hospital are as follows:

(a) The financial statements for the year ended June 30, 1987 relating to the operating fund have been prepared on the accrual basis and in accordance with the Hospitals and Charities regulations of 1983.

The financial statements relating to the Capital Fund and Special Purpose Fund have been prepared on a cash accounting basis.

Assets, Liabilities and related revenues and expenses have been segregated into Operating Fund, Capital Fund, Specific Purpose Fund and Nursing Home Society as provided in the Hospitals and Charities Regulations 1983. Unless otherwise directed by the Health Department, money received otherwise than a gift for specific purpose is paid into the Operating or Capital Fund and used as follows:

- (1) Government subsidies are used as directed by the Health Department.
- (2) Unconditional gifts are paid into either the Operating or Capital Fund as the committee directs.
- (3) Money derived from fees for service or from any other source not mentioned in (1) or (2) above is paid into the Operating Fund.
- (b) Investments held by the hospital are stated in the Balance Sheet at cost.
- (c) Income from Investments.
 - (1) Income from investment of Capital, Specific Purpose or Nursing Home Society Funds have been credited directly to the relevant fund.
 - (2) Income from investments has not been brought to account in determining the years operating result. This is consistent with prior years.
- (d) Stock on Hand.

Stock on hand includes all stores held in the General Store and Pharmacy. Stocks on hand are valued at latest purchase price which is consistent with prior years.

Variation in stock levels have been brought to account in the years operating result.

- (e) Property, plant, machinery and equipment are stated in the Balance Sheet at cost.
- (f) Depreciation of plant and equipment is determined on the basis of the straightline method, taking into consideration the anticipated economic usefulness of the asset.

No provision has been made for the depreciation or revaluation of buildings in accordance with Health Department instructions.

- (g) Provision for Long Service Leave has been calculated at employees current rates of pay. Entitlements have been calculated with reference to relevant awards which recognise the liability from the date of legal entitlement which is generally after 10 years of service.
- (h) The amount expected to be paid to employees for their pro-rata entitlement to annual leave is accrued annually at current pay rates.
- (i) In calculating provision for doubtful debts all amounts due to the institution for a period of 90 days or more have been brought to account.
