BUSINESS:

1. To confirm the minutes of the last Annual General Meeting held on the 16th May, 1974.
2. To receive and adopt the Report of the Board of Directors for the year ended 31st March, 1975.
3. To receive and adopt the Balance Sheet and Income and Expenditure Statement for the year ended 31st March, 1975.
4. To elect three Directors. Mr. D. R. Barker, Mr. J. R. Bridger and Mr. G. T. Peet retire by rotation, but are eligible for re-election and offer themselves accordingly.

 - (b) Subject to the rules of the Co-operative, and to security satisfactory to the Directors other than the applicant in each case, to loan an amount not exceeding four thousand dollars (\$4,000) to each of the undermentioned Directors and Officers.

DIRECTORS' REPORT

Ladies and Gentlemen,

On behalf of the Directors of this Co-operative it is my privilege to present for your consideration the Sixth Annual Report and Financial Statement for the year ended 31st March, 1975.

Once again it is pleasing to report that we have had a very successful year, more staff members are becoming aware of the benefits there are in being a member of the Co-operative and therefore there has been a lot more interest shown during the past year.

FINANCES.

The Finance Statement shows a surplus of \$3,821.85 after providing \$540.00 for income tax. This amount has been transferred to our reserves which now total \$6,934.00.

Considering that our interest rates on loans are now lower and our interest rates on savings equal to those available with Finance Companies and Banks, the surplus is very gratifying.

Further details of the finances can be seen on other pages of this report.

MEMBERSHIP.

During the year, 36 members withdrew their shares due to resignation from the staff, however 53 new members joined which gave an overall increase of 17 over last year.

Non member savers now total 143.

LOANS APPROVED.

136 loans were approved totalling \$143,384.00, details of which can be found elsewhere in this report.

Last year I mentioned that an amount of \$1,112.00 had been written off as a bad debt, this has now been almost fully paid. Your Credit Co-operative has been very fortunate that to date no money has been lost due to bad debts. This I believe is due to the way in which the Directors carefully consider each loan application.

SAVINGS.

The amount of money received for savings increased greatly as did also the amount of withdrawals, the total savings held at the 31st March, 1975 was much higher than the previous year.

Next January your Credit Co-operative will be commencing a Christmas Club, however you will hear more about this later in the year.

BOARD OF DIRECTORS.

The Board of Directors met 28 times during the year and the Finance Committee met a further six times. The Directors policy is that there should be as little delay as possible in dealing with any business.

During the year Messrs. R. Bruggeman, R. Parker and Miss M. M. Davies resigned from the Board as they left the employment of the hospital and Mr. I. E. Channing resigned because of long service leave. To these four past Directors we say thank you for your service to the Co-operative.

Messrs. J. R. Bridger, R. L. Peck, Mesdames M. Duggan and A. Sherritt replaced the above Directors and we trust that they will enjoy doing their share to help the Co-operative run smoothly and efficiently.

As Chairman of the Board, and on behalf of all the members I sincerely thank all the Directors for their help and co-operation given during the year. This has made my job as Chairman so much easier.

OFFICERS.

The Board of Directors were very sorry to lose the services of Mr. D. N. Rees as Secretary. Mr. Rees was one of the persons instrumental in forming the Credit Co-operative and I express here the Boards sincere appreciation of a job well done.

Our Treasurer, Mr. F. Clay was appointed Secretary and Mr. L. George is our new Treasurer.

In conclusion may I say that 1974-75 Credit Union year is now past, but let us all work together as best we can during this new year for the mutual benefit of all.
